The term "Just Transition" was coined in the 1990s by North American trade unions to address job losses associated with environmental policies. Principles include availability and training for new high-quality jobs and an opportunity for workers to provide input through collective bargaining and advisory processes. This session will focus on how companies are preparing their workforce for the EV transition, and what more government can do. We will seek to delve into specific situations and company practices such as how the workforce at a traditional fossil fuel vehicle factory is trained to produce electric vehicles.

In the fossil fuel economy, communities of color and low-income neighbourhoods have borne the brunt of many types of pollution. In this panel, we will focus on unhealthy levels of air pollution—often concentrated in neighbourhoods from heavy-duty trucks, highways, and ports—that have led to higher asthma rates, higher health care costs, and shorter life expectancy. Additionally, many studies show that these same communities benefit less from policies designed to reduce emissions from transportation as older, dirtier vehicles remain on the road in underserved neighbourhoods long after cleaner vehicles arrive in wealthy areas. Underserved communities also struggle to access newer and cleaner technologies as cost and other barriers may be prohibitive. As we transition to electric vehicles, how can we ensure these deeply impacted communities are not left waiting until the newer, cleaner technologies just "trickle down" to their areas? This panel seeks to bring together representatives from the government, disadvantaged communities, and city leaders.

Keynote plenary focusing on the relevant parts of the US Infrastructure Law and the AFIR proposal followed by audience Q&A.

Two major pieces of policymaking relevant to both HDV and LDV infrastructure are being developed and implemented in the US and EU. In the US, the bipartisan infrastructure law is now in place. One key piece of the law is that \$5 billion dollars in funding will be given to states to build out a national EV charging network along corridors. The state plans are due in August and will likely be approved by the end of September. In addition, other grants for EV charging are being given out as part of the law. In the EU, the European Commission has proposed the Alternative Fuels Infrastructure Regulation (AFIR) which will going through trialogue negotiations starting in the September timeframe. While these policies are a critical starting point, neither is sufficient to drive the level of charging infrastructure that will be needed to support the EV transition. This session will focus on what opportunities this regulation/legislation presents and what they mean for the LDV and HDV EV market, fleets, utilities, charge point operators, and others. In addition, what more can government and other stakeholder do to drive investment in further developing EV infrastructure.

As a global consensus builds around the vision of electric vehicles as the "new normal," it seems prudent to identify potential challenges that could delay or even derail the transition and then seek potential solutions to get out ahead and prevent these risks. Consider the following incomplete list of risks: Lack of infrastructure, Battery cost parity is delayed, Shortages of critical metals and minerals, Long-haul tractor trailer trucks split between battery and fuel cell solutions, Mainstream consumers prefer staying with traditional vehicles, Questions around e-fuels, natural gas and biofuels delay transition to truly zero emission vehicles, and so on. Speakers in this session will explore potential pitfalls and propose possible solutions.
